Executive Director Update: Meghan

- Noteworthy since the June meeting:
 - Sustainability Education Forum for faculty thanks to Daita's efforts Over 142 participants
 - o STARS 3.0 launch getting closer nearly all categories completed with public comment
 - AASHE Conference about 75 in-person sessions at conference. Thinking about adding a virtual event in November to utilize more education proposals submitted
 - All signs point to a successful in-person conference. 1500 attendees is maximum capacity.
 - Kimberly is already working on a 2024 conference location. Possible announcement of 2024 location at 2023 conference closing. Board members will be informed ahead of any public announcement
