

# **AASHE 2024 Registration & Participation Policies**

## **Refunds/Cancellations**

Requests for cancellations and/or refunds will be accepted until 11:59 p.m. (PST) September 15, 2024, and a **5% administrative fee will be deducted**. Please note that this fee will be incurred for all cancellation/refund requests regardless of when they are received. No refunds will be granted after **September 15, 2024**. Once a registration has been charged to a credit card, AASHE is not able to change the credit card used for payment. Refunds will be credited using the original method of payment less the cancellation fee. Refunds will not be issued for no-shows. #### No Substitutions

AASHE does not allow substitutions on registrations. If you are unable to attend, you will need to cancel your registration by the cancellation cutoff date of **September 15, 2024** for a refund, minus the 5% administrative fee. No refunds will be granted after **September 15, 2024**.

#### Member/Non-Member Rate

AASHE members receive a discounted registration rate, which is the lowest rate for the conference. If you are a member, please select "AASHE Member Registration." The ticket rates that show are the discounted member rates. You may search the <u>AASHE Membership Directory</u> to see if your institution or company is a member. You must use the organizational email address associated with your membership to register. Registration is based on the current status of membership (at the time of registration for conference). If an organization becomes a member subsequent to registration, no price differentials will be issued.

#### **Payment Policy**

Check payments will be accepted until **September 15, 2024** and must be sent within **45 days of invoice receipt**. If your payment is not received within 45 days, your registration may be canceled. If paying by check, please be sure to allow two (2) weeks for delivery and receipt. If payment is not received within 45 days of your registration, AASHE will cancel your registration and you will have to register at the rate that is in place when you re-register.

**Please include a copy of the invoice or confirmation email with your check**. Payment information is provided on your invoice.

Fees for the AASHE Conference & Expo are not tax deductible as charitable contributions but may be deductible as ordinary business expenses.
